In this case, Smith reinvested in an additional 100 shares four days prior to selling 100 shares of the same stock at a loss. The \$2,000 disallowed loss would, however, increase the basis of the new shares by \$2,000. Choice "b" is incorrect. The \$2,000 loss realized in 1993 is disallowed under the wash sale rules.
