Explanation: Explanation: The reason DSW2 has not become the active switch for Vlan103 is because the priority value of DSW1 is higher than that of DSW2. In order to make DSW2 become the active switch, we need to increase DSW2's priority (to higher than 200)

or decrease DSW1's priority (to lower than 190) -> B and C are correct. But there is another requirement from this question that "A failure on gig1/0/1 on primary device should cause the primary device to release its status as the primary device, unless GigabitEthernet 1/0/1 on backup device has also failed". This requirement makes answer B incorrect. For example, we choose to decrease the priority value on DSW1 to 160 (according to answer B) then DSW2 will become active switch (that is good). When Gi1/0/1 on DSW2 goes down, the priority of DSW2 will be $190 - 50 = 140 < 160$ -> DSW1 will become new active switch (it is good, too). But when Gi1/0/1 on DSW1 also goes down, the priority of DSW1 will be $160 - 10 = 150$ and it is still greater than 140 of DSW2 -> DSW2 cannot retake the active role as the requirement of this question.
