The cost of common equity can be calculated using three methods, the Capital Asset Pricing Model (CAPM), the Dividend- Yield-plus-Growth-Rate (or Discounted Cash Flow) approach, and the Bond- Yield-plus-Risk-Premium approach. In this example, you are asked to calculate the cost of common equity using the Dividend-Yield- plus-Growth-Rate, or Discounted Cash Flow, approach. To calculate the cost of common equity using this approach, divide the expected annual dividend by the selling price of the outstanding common stock, and add the expected growth rate. Using the DCF method, the cost of common equity can be found as follows: $\{[\$0.80/\$30.90] + 9.75\% \} = 12.34\%$. The after-tax cost of debt can be found by multiplying the yield to maturity of the firm's outstanding long-term debt (9.5%) by (1-tax rate). Using this method, the after-tax cost of debt is found as 6.175%. The calculation of the cost of perpetual preferred stock is relatively straightforward, simply divide the annual preferred dividend by the net offering price. Using this method, the cost of preferred stock is found as

6.327%. Incorporating these figures into the WACC equation gives the answer of 8.355%.
