Because the risks that exist with VPNs, where the machine can act as a router between the Internet and the corporate network is not valid with DirectAccess. IPsec rules on the UAG server require that traffic be from an authenticated source, and all traffic between the DA client and server is protected with IPsec. Thus, in the scenario where the DA client might be configured as a router, the source of the traffic isn't going to be the DA client, and authentication will fail - hence preventing the type of routing that VPN admins are concerned about.
