**Answer: A**  
**Explanation:** You've assigned a policy that requires security, but have not configured clients with an IPsec policy to respond to these requests. So the simplest fix is obviously to deploy a Client (Respond Only) policy. This needs to be assigned to all client computers that will connect to Server1, not to Server1 itself. **WRONG ANSWER** Server (Request Security) would conflict with the existing Require Security policy, and could potentially allow clients to communicate that are not encrypting. The purpose of the policy agent is to retrieve IPsec policy information and pass it to the other IPsec mechanisms that require that information to perform security services. (MY NOTE: Although IPsec communication is not working, we have no indication the clients have been assigned a policy, so we shouldn't worry yet about the Policy Agent) Reference:
