External data used during the modeling is stored in on-premises SQL Server 2016 databases and CSV files stored in an Azure Data Lake Storage Gen2 storage account. \*

Information about vehicles that have been detected as going over the speed limit during the last 30 minutes must be available to law enforcement officers. Several law enforcement organizations may respond to speeding vehicles. \* The solution must allow for searches of vehicle images by license plate to support law enforcement investigations. Visual MonitoringThe visual monitoring system is a network of approximately 1,000 cameras placed near highways that capture images of vehicle traffic every 2 seconds. The cameras record high resolution images. Each image is approximately 3 MB in size.
