In extreme cases, such as when background levels exceed 55 dBA for an sustained period of time, gating or sound-suppression effects may occur in the Cisco TelePresence audio. These effects occur when the system can no longer distinguish between background noise and speech, ultimately causing the system to suppress most sound because it identifies that sound as background noise. The most common causes of background noise are as follows:

- Noise from HVAC air movement
- Noise from HVAC machinery or other machinery
- External sounds such as street traffic
- Adjacent room noise (server rooms, break rooms, bathrooms, or kitchens)
