Dividends and splits are applied to all shares issued or repurchased and all original or adjusted shares outstanding prior to the split or dividend. Step 1) Apply the 04/01/01 dividend to the beginning of year shares: Adjusted shares = 1.05 x 20,000 = 21,000. Step 2) Apply the 10/01/01 split to the adjusted beginning-of-year shares and the repurchase. Adjusted beginning-of-year shares = 42,000 (= 2 x 21,000). Adjusted repurchase = 10,000 (= 2 x 5,000). Step 3) Compute the weighted average number of shares.  $4 \times 2,000(12/12) - 10,000(6/12) = 37,000$  shares.
