Explanation: Companies have tax obligations to be fulfilled, so financial data cannot be deleted. The data subject has several rights under the GDPR, however there are limitations. These rights cannot run counter to other specific legislation. In this case, the holder can exercise the right of Opposition instead of Exclusion. In the Right of Opposition, he requests the Controller to cease the processing of his data for non-consented purposes. An example of Opposition: in Brazil there was the website [naomeperturbe.com.br](http://naomeperturbe.com.br), where millions of Brazilians could oppose the inconvenient calls made by the telecommunication service providers.
