Explanation: Explanation The current Basel rules for the basic VaR based charge for market risk capital set market risk capital requirements as the maximum of the following two amounts: 1. 99%/10-day VaR, 2. Regulatory Multiplier x Average 99%/10-day VaR of the past 60 days The 'regulatory multiplier' is a number between 3 and 4 (inclusive) calculated based on the number of 1% VaR exceedances in the previous 250 days, as determined by backtesting. - If the number of exceedances is ≤ 4 , then the regulatory multiplier is 3. - If the number of exceedances is between 5 and 9, then the multiplier = $3 + 0.2 \cdot (N - 4)$, where N is the number of exceedances. - If the number of exceedances is ≥ 10 , then the multiplier is 4. So you can see that in most normal situations the risk capital requirement will be dictated by the multiplier and the prior 60-day average VaR, because the product of these two will almost often be greater than the current 99% VaR. The correct answer therefore is = $\max(200\text{mm}, 3 \cdot 250\text{mm}) = \750mm . Interestingly, also note that a 99% VaR should statistically be exceeded $1\% \cdot 250 \text{ days} = 2.5$ times, which means if the bank's VaR model is performing as it should, it will still need to use a reg multiplier of 3.
