Much in her manner, and more in her face, said plainly and sadly: I am the wreck of something that you might once have liked to see; a wreck that can never be repaired--that must drift on through life unnoticed, unguided, unpitied--drift till the fatal shore is touched, and the waves of Time have swallowed up these broken relics of me forever. This was the story that was told in Sarah Leeson's face--this, and no more. No two men interpreting that story for themselves, would probably have agreed on the nature of the suffering which this woman had undergone. It was hard to say, at the outset, whether the past pain that had set its ineffaceable mark on her had been pain of the body or pain of the mind. But whatever the nature of the affliction she had suffered, the traces it had left were deeply and strikingly visible in every part of her face. Her eyes, viewed apart from their prevailing expression of uneasiness
