If users access your objects directly in Amazon S3, they bypass the controls provided by CloudFront signed URLs or signed cookies, for example, control over the date and time that a user can no longer access your content and control over which IP addresses can be used to

access content. In addition, if user's access objects both through CloudFront and directly by using Amazon S3 URLs, CloudFront access logs are less useful because they're incomplete. Option A is invalid because you need to create an Origin Access Identity for CloudFront and not an IAM user. Option C and D are invalid because using policies will not help fulfil the requirement.
