EX1 and EX2 are the members of a database availability group (DAG) named DAG1. Trey Research has three databases named DB1, DB2, and DB3. DB1 and DB2 replicate between all of the servers in DAG1. DB3 is mounted on EX4. The storage on EX1 and EX2 is configured as shown in the following table. Resource Utilization Requirements Users report that their connection to Outlook Web App is slow since the deployment of IMAP on EX4. The users do not report that they experience performance issues when they use their mobile device.
