One mobile application will be used by employees; the other will be used by customers. Litware plans to move to a more agile development methodology. Shared code will be extracted into a series of packages. Litware has started an internal cloud transformation process and plans to use cloud-based services whenever suitable. Litware wants to become proactive in detecting failures, rather than always waiting for customer bug reports. Technical requirements The company's investment planning applications suite must meet the following requirements: New incoming connections through the firewall must be minimized. Members of a group named Developers must be able to install packages. The principle of least privilege must be used for all permission assignments. A branching strategy that supports developing new functionality in isolation must be used. Members of a group named Team Leaders must be able to create new packages and edit the permissions of package feeds. Visual Studio App Center must be used to centralize the reporting of mobile application crashes and device types in use. By default, all releases must remain available for 30 days, except for production releases, which must be kept for 60 days. Code quality and release quality are critical.
