Sub1 is associated to an Azure Active Directory (Azure AD) tenant named litwareinc.com. The tenant contains the user objects and the device objects of all the Litware employees and their devices. Each user is assigned an Azure AD Premium P2 license. Azure AD Privileged Identity Management (PIM) is activated. The tenant contains the groups shown in the following table. The Azure subscription contains the objects shown in the following table. Azure Security Center is set to the Free tier.

Planned changes Litware plans to deploy the Azure resources shown in the following table. Litware identifies the following identity and access requirements:

- * All San Francisco users and their devices must be members of Group1.
- * The members of Group2 must be assigned the Contributor role to Resource Group2 by using a permanent eligible assignment.
- * Users must be prevented from registering applications in Azure AD and from consenting to applications that access company information on the users' behalf.

Platform Protection Requirements Litware identifies the following platform protection requirements:

- * Microsoft Antimalware must be installed on the virtual machines in Resource Group1.
- * The members of Group2 must be assigned the Azure Kubernetes Service Cluster Admin Role.
- * Azure AD users must be able to authenticate to AKS1 by using their Azure AD credentials.
- * Following the implementation of the planned changes, the IT team must be able to connect to VM0 by using JIT VM access.
- * A new custom RBAC role named Role1 must be used to delegate the administration of the managed disks in Resource Group1. Role1 must be available only for Resource Group1.
