**Enabling Advanced Audit Policy Configuration**  
Basic and advanced audit policy configurations should not be mixed. As such, it's best practice to enable Audit: Force audit policy subcategory settings (Windows Vista or later) to override audit policy category settings in Group Policy to make sure that basic auditing is disabled. The setting can be found under Computer Configuration>Policies>Security Settings>Local Policies>Security Options, and sets the SCENoApplyLegacyAuditPolicy registry key to prevent basic auditing being applied using Group Policy and the Local Security Policy MMC snap-in.  
In Windows 7 and Windows Server 2008 R2, the number of audit settings for which success and failure can be tracked has increased to 53. Previously, there were nine basic auditing settings under Computer Configuration>Policies>Windows Settings>Security Settings>Local Policies>Audit Policy. These 53

new settings allow you to select only the behaviors that you want to monitor and exclude audit results for behaviors that are of little or no concern to you, or behaviors that create an excessive number of log entries. In addition, because Windows 7 and Windows Server 2008 R2 security audit policy can be applied by using domain Group Policy, audit policy settings can be modified, tested, and deployed to selected users and groups with relative simplicity.
