CBAC inspectstraffic that travels through the device to discover and manage state information for TCP and UDP sessions.The device uses this state information to create temporary openings to allow return traffic and additional data connections for permissible sessions.CBAC creates temporary openings in access lists at firewall interfaces. These openings are created wheninspected traffic exits your internal network through the firewall. The openings allow returning traffic \(thatwould normally be blocked\) and additional data channels to enter your internal network back through thefirewall. The traffic is allowed back through the firewall only if it is part of the same session as the originaltraffic that triggered inspection when exiting through the firewall.Inspection rules are applied after your access rules, so any traffic that you deny in the access rule is notinspected. The traffic must be allowed by the access rules at both the input and output interfaces to be inspected.
