**Explanation:** Differential (incremental) cost is the difference in total cost between two decisions. The relevant costs do not include unavoidable costs, such as the US \$3 of fixed overhead. It would cost ABC an additional US \$20,000 to purchase, rather than manufacture, the components. The segmented income statement for a retail company with three product lines is presented below: The company buys the goods in the three product lines directly from manufacturers' representatives. Each product line is directed by a manager whose salary is included in the administrative expenses. Administrative expenses are allocated to the three product lines equally because the administration is spread evenly among the three product lines.
