Proseware is located in Europe and has a Lync Server 2010 infrastructure.Contoso must minimize hardware and software purchasing costs, while guaranteeing performance levels for all Skype for Business Server 2015 workloads.Planned ChangesContoso plans to implement the following workloads in the Skype for Business Server 2015 deployment:FederationDial-in conferencingExternal user accessAudio, video, and web conferencingThe ability to host Lync meetings that have external participantsThe FQDNs of the edge services will be configured as shown in the following table. Technical RequirementsContoso identifies the following technical requirements for the

planned deployment: Only federation to Proseware must be allowed. All of the edge services must use default ports. Wide area network (WAN) traffic and Internet traffic must be minimized. All of the user contacts stored in Skype for Business Server 2015 must be backed up. The sales department must have a dedicated dial-in conferencing number. All other users in both the United States and Europe must use a pool of regional dial-in conferencing numbers. If a single component fails, all Skype for Business services must remain available without the need for manual intervention. Performance degradation is acceptable during a component failure state.
