**Note:** A common table expression (CTE) can be thought of as a temporary result set that is defined within the execution scope of a single SELECT, INSERT, UPDATE, DELETE, or CREATE VIEW statement. Unlike a derived table, a CTE can be self-referencing and can be referenced multiple times in the same query.
