**Task 4:**The developers at your company plan to create a web app named App10317806 and to publish the app to <https://www.contoso.com>. You need to perform the following tasks:

- \* Ensure that App10317806 is registered to Azure Active Directory (Azure AD).
- \* Generate a password for App10317806.

**Task 5:**You need to prevent administrative users from accidentally deleting a virtual network named VNET1. The administrative users must be allowed to modify the settings of VNET1.

**Task 6:**You need to ensure that a user named user210317806 can manage the properties of the virtual machines in the RG1lod10317806 resource group. The solution must use the principle of least privilege.

**Task 7:**You need to ensure that only devices connected to a 131.107.0.0/16 subnet can access data in the railod10317806 Azure Storage account.

**Task 8:**You need to email an alert to a user named [\[email&#160;protected\]](#) if the average CPU usage of a virtual machine named VM1 is greater than 70 percent for a period of 15 minutes.

**Task 9:**You need to collect all the audit failure data from the security log of a virtual machine named VM1 to an Azure Storage account. To complete this task, sign in to the Azure portal. This task might take several minutes to complete. You can perform other tasks while the task completes.

**Task 10:**You need to prevent HTTP connections to the rg1lod10317806n1 Azure Storage account.

**Task 11:**You need to ensure that the rg1lod10317806n1 Azure Storage account is encrypted by using a key stored in the KeyVault10317806 Azure key vault.

**Task 12:**You need to create a new Azure Active Directory (Azure AD) directory named 10317806.onmicrosoft.com. The new directory must contain a user named user10317806.onmicrosoft.com who is configured to sign in by using Azure Multi-Factor Authentication (MFA).
