For example, when you upgrade to R80 from earlier versions: Gateways that have the Firewall and the Application Control Software Blades enabled will have their Access Control Policy split into two ordered layers: Network and Applications. When the gateway matches a rule in a layer, it starts to evaluate the rules in the next layer. Gateways that have the IPS and Threat Emulation Software Blades enabled will have their Threat Prevention policies split into two parallel layers: IPS and Threat Prevention. All layers are evaluated in parallel.
