**Explanation:** Explanation/Reference: An identity-based access control is an example of discretionary access control that is based on an individual's identity. Identity-based access control (IBAC) is access control based on the identity of the user (typically relayed as a characteristic of the process acting on behalf of that user) where access authorizations to specific objects are assigned based on user identity. Rule Based Access Control (RuBAC) and Role Based Access Control (RBAC) are examples of non-discretionary access controls. Rule-based access control is a type of non-discretionary access control because this access is determined by rules and the subject does not decide what those rules will be, the rules are uniformly applied to ALL of the users or subjects. In general, all access control policies other than DAC are grouped in the category of non-discretionary access control (NDAC). As the name implies, policies in this category have rules that are not established at the discretion of the user. Non-discretionary policies establish controls that cannot be changed by users, but only through administrative action. Both Role Based Access Control (RBAC) and Rule Based Access Control (RuBAC) fall within Non Discretionary Access Control (NDAC). If it is not DAC or MAC then it is most likely NDAC.

**BELOW YOU HAVE A DESCRIPTION OF THE DIFFERENT CATEGORIES:**

**MAC = Mandatory Access Control** Under a mandatory access control environment, the system or security administrator will define what permissions subjects have on objects. The administrator does not dictate user's access but simply configure the proper level of access as dictated by the Data Owner. The MAC system will look at the Security Clearance of the subject and compare it with the object sensitivity level or classification level. This is what is called the dominance relationship. The subject must **DOMINATE** the object sensitivity level. Which means that the subject must have a security clearance equal or higher than the object he is attempting to access. MAC also introduces the concept of labels. Every object will have a label attached to them indicating the classification of the object as well as categories that are used to impose the need to know (NTK) principle. Even though a user has a security clearance of Secret it does not mean he would be able to access any Secret documents within the system. He would be allowed to access only Secret documents for which he has a Need To Know, formal approval, and object where the user belongs to one of the categories attached to the object. If there is no clearance and no labels then it is **NOT** Mandatory Access Control. Many of the other models can mimic MAC but none of them have labels and a dominance relationship so they are **NOT** in the MAC category.

**DAC = Discretionary Access Control** DAC is also known as: Identity Based access control system. The owner of an object is defined as the person who created the object. As such the owner has the discretion to grant access to other users on the network. Access will be granted based solely on the identity of those users. Such a system is good for low level of security. One of the major problems is the fact that a user who has access to someone's else file can further share the file with other users without the knowledge or permission of the owner of the file. Very quickly this could become the wild wild west as there is no control on the dissemination of the information.

**RBAC = Role Based Access Control** RBAC is a form of Non-Discretionary access control. Role Based access control usually maps directly with the different types of jobs performed by employees within a company. For example there might be 5 security administrators within your company. Instead of creating each of their profiles one by

one, you would simply create a role and assign the administrators to the role. Once an administrator has been assigned to a role, he will IMPLICITLY inherit the permissions of that role. RBAC is a great tool for environment where there is a large rotation of employees on a daily basis such as a very large help desk for example. RBAC or RuBAC = Rule Based Access Control. RuBAC is a form of Non-Discretionary access control. A good example of a Rule Based access control device would be a Firewall. A single set of rules is imposed to all users attempting to connect through the firewall.
